



ARTICLES OF INCORPORATION OF AMERICAN MADE BASEBALL CALIFORNIA PUBLIC BENEFIT CORPORATION

Article I: The name of this corporation is American Made Baseball. The street address of the corporation is 117 Silver Pine Ct Galt, Ca 95632.

Article II: A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific purposes for which this corporation is organized are to educate youth on the fundamentals of competitive baseball while educating and promoting character building skills. The means of providing such education includes, but is not limited to, providing a supervised baseball program structured under the rules and regulations of the United States Specialty Sports Association (also known as the USSSA) and/or similar youth baseball programs.

Article III: The name and address in the State of California of this corporation's initial agent for service of process is Miguel Lourence, 117 Silver Pine Ct. Galt, CA 95632

Article IV: A. This corporation is organized and operated exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

B. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contribution to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

C. No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.


